The member will be billed a registration fee of \$30.00 plus tax. IF THIS FORM IS SUBMITTED 3 DAYS OR LESS PRIOR TO ARRIVAL, THE MEMBER WILL BE BILLED \$50.00 plus tax. The Club Administrative office must be notified of a cancellation of a guest's visit at least two business days prior to the arrival date. Failure to advise the Club of a cancellation may result in the Member's club account being charge the registration fee.

The maximum length of stay to extend privileges is two (2) weeks.

PETS ARE NOT ALLOWED AT ANY TIME FOR HOUSEGUESTS

Guest may pay by credit card at the time of transactions for any guest fees, cash is not accepted.
